Registration fee is \$50 for vendors and \$ 100 for food vendors. All vendors – you are welcome to promote a percentage of sales to HSJC and be given a tax donation form after tally and donation is given.

## What you need to know:

-  Spaces are approximately 10'x10' and do not include any electric outlets. Only one space can be reserved per animal related business 50.00 fee payable online or check made out to HSJC. After July 16<sup>th</sup>, if available, additional space can be requested for an additional fee of \$25. Non profits are no charge for single space.
-  All vendors are expected to occupy their booth for the entire event. Break down begins at 7pm.
-  You are reserving a space only. Tent, tables, chairs, signage, etc. must be provided by you! You will be responsible for your own set up and tear down. All items brought in, including trash, must be removed by you at the completion of the event. All tents must be weighted – no stakes allowed!
-  Vehicles will not be permitted on the grass or on the sidewalks at anytime during the event.
-  Setup time begins at 10am. All vendors must be checked in and unloaded in by 12:30. If you have not checked in prior to 12:30pm you will not be allowed to set up.
-  The first 100 dogs will each receive a goodie bag. If you are interested in having a promotional item included, please deliver 100 items to Town Hall by August 3<sup>rd</sup>.
-  Rain or shine event – no refunds!
